**To refugees in Yemen who have pending applications with the U.S. resettlement program:**

Please be informed that your case is now being processed by the Resettlement Support Center (RSC), Middle East/North Africa (MENA) based in Amman, Jordan.

Due to the on-going security situation and the temporary closure of the U.S. Embassy in Sana'a, U.S. officials and RSC MENA staff are unable to conduct interviews in Yemen. We are unable to predict when these interviews will resume.

One of our highest priorities is facilitating timely travel to the United States for all individuals who are cleared for U.S. entry and we will continue to do so as long as security conditions permit. Please be advised that:

- For those who have not yet completed their medical exams, we assure you that we are doing everything we can to schedule you for an exam;
- For those who have not yet had an interview with RSC TUME or a U.S. immigration official, we will do everything we can to schedule interviews once conditions permit;
- All refugees designated for resettlement to the United States must be interviewed in person by an officer from United States Citizenship and Immigration Services (USCIS, part of the U.S. government). RSC MENA will notify you when processing is possible.

We are aware that some applicants may have relocated inside or outside Yemen due to security concerns. We cannot advise whether or not you should leave. Only you can assess your own personal safety situation. If you move to a neighbouring country, RSC MENA will do our best to facilitate continued processing in your new location. If you move, please contact the nearest UNHCR office. Also send your new contact information to the RSC MENA Information Center at [ic@iom.int](mailto:ic@iom.int) or call us at +962 6 562 5077. We will counsel you on options at that point.
